Hello Elizabeth,

Thank you for the contact information. We have already put that to use as we have hired a surveyor to set some missing property pins adjacent to the range.

As for the long term solution:

We recognize that you will need to look at a variety of solutions. Since we are motivated to find a permanent location for your range, we want to offer some options on our own property.

We could facilitate an indoor or outdoor range on one of the parcels marked either "Barr" or "Garcia" on the attached (2009Phase1) map.

In general we would consider a number of options. From leasing a facility built to suit your needs, to selling raw land.

You may want to reconsider the desire for an outdoor range. Based on the existing facility you may find that it requires a site that is a half mile or more deep, and nearly as wide. Also, due to concerns about lead deposits and liability, land owners today may be reluctant to lease an open range.

As one possibility I have attached a layout (MNIP A range) of a modular indoor range (see <a href="http://www.ais-sim.com/video/quickrange\_cgi.swf">http://www.ais-sim.com/video/quickrange\_cgi.swf</a>) on a parcel adjacent to the Nogales station (building on bottom is Nog Station). On this layout we included a range manager office along with the modular range and graded it to connect with the existing parking lot.

If you give us an idea what features would be useful (Number & length of bays, office/armory space, co-located fitness center, air soft field

etc.)

we would be glad to do a quick layout on various parcels.
